Please review this Speaker Agreement for SAFE™ Forum 2026 (the "Agreement") and return a signed copy by [June 12, 2026].

This Agreement is made effective as of [July 1, 2026]. By executing this Agreement and participating as a speaker at SAFE™ Forum KR 2026 ("Event"), you ("You," "Your," or "Speaker") expressly acknowledge and agree with Samsung Electronics Co., Ltd., acting through its Foundry Business ("Samsung"), to the following:

1. You will not be paid for Your services as a Speaker, nor will Your expenses be reimbursed, unless You have a separate written agreement with Samsung regarding the Event.
2. Upon Samsung's request, You agree to provide a copy of Your presentation and other related materials to Samsung ("Presentation Materials") in advance of the Event for Samsung's review. You further agree to provide a final copy of Your Presentation Materials to Samsung within a reasonable amount of time after the Event. You will use reasonable efforts to adhere to Samsung's presentation and speaker guidelines for the Event, including, but not limited to, deadlines for producing materials, presentation file format (PowerPoint file), presentation content and length, and other requirements. Samsung shall reproduce any copyright or other legal notices that You include in Your submitted Presentation Materials.
3. You represent and warrant that Your Presentation Materials do not violate any third-party's intellectual property rights, including but not limited to, copyright, patent, trademark, trade secrets, and privacy rights. You understand that in the event that any Presentation Materials contain the work of other individuals or organizations, including, but not limited to, copyrighted music, images, or other materials, it is Your responsibility to secure any necessary permissions and/or licenses to use such Presentation Materials in connection with this Event from the owner of such work. You certify that You have secured the necessary permissions from the third-party owner to use any such third-party materials or have not used any third-party materials in Your Presentation Materials.
4. You agree and give permission to Samsung to take photos and record videos of Your presentation at the Event, including Your Presentation Materials. You hereby grant Samsung a nonexclusive,

9. You will maintain confidentiality of all the terms, conditions, and arrangements contained herein, including this Agreement and its terms.

10. This Agreement is governed by the laws of the Republic of Korea and may not be modified except by a writing signed by both parties.
